VENDOR DETAILS

Vendor spaces cost \$65 per 10-by-10-foot space. Each vendor will be responsible for their own table, chairs, and tent. Vendors cannot drive on the grass in the park. If you need to make special arrangements for set-up, please call us in advance. Electricity is available for an additional \$10 on a first-come, first-serve basis. Vendor set-up takes place from 7 a.m. to 9 a.m.

Vendors are asked to donate an item for our raffle (minimum \$10 value). Please turn in your raffle item the day of the event. Booths are encouraged to offer a fun game or activity.

ABOUT HSCA

Founded by concerned citizen Miss Evelyn Sweitzer in 1941, Humane Society Calumet Area aims to lead the community in the humane treatment of animals by providing vital community services. In 2015, 1,352 homeless animals found homes through HSCA and 124 lost animals were reunited with their families. Additional HSCA services include spay and neuter surgeries for families with financial hardship at Estelle Marcus Animal Clinic, a humane education team that teaches local children about pet safety and compassion, and rehabilitation for wildlife at Moraine Ridge Wildlife Rehabilitation Center.
